The Office of the Commissioner requests this extension in order to facilitate the implementation of the Accella software system and its integration with the Division of Water Quality. The incumbent of the position has been the project manager of the software operation since its inception and the need for continuity is of paramount importance in order to provide continuation of this important project. Funds are budgeted for current budget year and future needs will be requested as part of the FY 18 budget process. (L1137-16) (Maxwell/Hamilton)
