Motion by Gibbs to amend sections 1(b)(1) and (2) of the proposed snow shoveling ordinance to strike the words "or occupant." Seconded by Akers. Motion passed 14-1. Kay, Akers, Stinnett, Scutchfield, Mossotti, Henson, F. Brown, Lamb, Gibbs, Moloney, J. Brown, Evans, Bledsoe and Plomin voted yes. Farmer voted no.

Motion by Gibbs to amend section 1(b)(1) of the proposed snow shoveling ordinance to replace "an accumulation of two (2) or more inches" with "an accumulation of four (4) or more inches." Seconded by Kay. Motion passed 14-1. Kay, Akers, Stinnett, Scutchfield, Mossotti, Henson, F. Brown, Lamb, Gibbs, Moloney, J. Brown, Evans, Bledsoe and Plomin voted yes. Farmer voted no.

Motion by Lamb to amend and add the following language to the ordinance: "effective upon passage of Council." Seconded by J. Brown. Motion passed 13-2. Kay, Akers, Stinnett, Scutchfield, Mossotti, Henson, F. Brown, Lamb, Gibbs, Moloney, J. Brown, Bledsoe and Plomin voted yes. Farmer and Evans voted no.
