

# SCHEDULE 1 TO LEAP SERVICE AGREEMENT

## Pricing

#### 1. PRICING

Customer shall pay to NeuStar the fees set forth in this Schedule 1 (the "Annual Subscription Fee"). Payment in full of the Annual Subscription Fee entitles Customer to a site license to access the Service provided under the LEAP Service Agreement. For purposes of the LEAP Services Agreement and this Schedule, a "Transaction" shall mean the processing by NeuStar of a telephone number submitted to the Law Enforcement Analytical Platform (LEAP); i.e. one telephone number submitted to LEAP and processed by NeuStar results in one Transaction.

Customer shall elect an Annual Subscription Fee and associated tier of Transaction Level set forth in the table immediately below. In exchange for payment of the Annual Subscription Fee, Customer shall be entitled to the amount of Transactions selected in the Transaction Level for each twelve-month period of the Term (as defined in Section 2 below).

Subscription Level	Transaction Level	Annual Subscription Fee
Bronze	0 – 2,000	\$500
Silver	0 - 25,000	\$2,000
Gold	0 - 50,000	\$3,200
Platinum	0-200,000	\$5,000

If the amount of Transactions processed exceeds the Transaction Level selected above, then Customer shall pay to NeuStar an incremental charge equal to \$0.50 per Transaction for those Transactions above the Transaction Level.

#### 2. TERM

The LEAP Service Agreement shall take effect on the last date of execution (its Effective Date), and continue in full force and effect for 3 yrs thereafter (the "Term"). If Customer does not elect a Term, the Term is deemed to equal one (1) year.

#### 3. BILLING AGENTS

If Customer desires for NeuStar to send invoices directly to Customer's billing agent (the "Billing Agent"), then Customer must send to NeuStar a written letter of agency that (a) identifies and appoints a third party as Customer's Billing Agent for purposes of receiving invoices and making payment thereunder, (b) authorizes NeuStar to send Customer's invoices to the Billing Agent, and (c) authorizes the Billing Agent to pay to NeuStar, on behalf of Customer, all amounts that may be due under the LEAP Service Agreement. Notwithstanding the preceding, Customer remains ultimately responsible for the payment of all amounts due under the LEAP Service Agreement,



unless otherwise provided by applicable law. This limited authorization is revocable at any time upon written notification to NeuStar and Billing Agent.

### 4. NPAC AND LEAP SERVICE AGREEMENT

The LEAP Data Elements provided to Customer under the Service is derived from the regional, United States Number Portability Administration Center (NPAC) under administration by NeuStar. Customer's access to LEAP and use of LEAP Data Elements is subject to the requirements of the LEAP Service Agreement.

#### 5. CONNECTIVITY CHARGES

NeuStar offers Virtual Private Network (VPN) connectivity to Customers for the purpose of accessing LEAP. If elected by Customer, the charge for such VPN connectivity equals Five Hundred Dollars (\$500) per year.
