A RESOLUTION CHANGING THE PROPERTY ADDRESS NUMBERS OF 2300 PARIS PIKE TO 2324 PARIS PIKE AND CHANGING THE STREET NAMES AND PROPERTY ADDRESS NUMBERS OF 100 CHILESBURG ROAD TO 4301 ATHENS BOONESBORO ROAD, 160 CHILESBURG ROAD TO 300 HANNAH TODD PLACE, 150 CHILESBURG ROAD TO 316 HANNAH TODD PLACE, 2250 INNOVATION DRIVE TO 2259 JAGGIE FOX WAY, 225 REGENCY CIRCLE TO 2025 REGENCY ROAD, ALL EFFECTIVE THIRTY (30) DAYS FROM PASSAGE.

WHEREAS, the Lexington-Fayette Urban County Government has created a Geographic Information System ("GIS"); and

WHEREAS, the GIS street mapping and addressing project is the foundation for the Urban County Government's enhanced 911 Emergency Telephone Communication System (the "911 System"); and

WHEREAS, in order for the GIS and 911 Systems to function properly it is imperative that street names and property addresses conform to the standards established in Section 17-2 through 17-4 of the Code of Ordinances; and

WHEREAS, various street names and property addresses located in several Council Districts do not meet the Code requirements and changes should be made to conform to the Code and to accomplish the goals of the GIS and 911 System projects.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT:

Section 1 – That the property address numbers of the following properties be and hereby are changed as follows:

(a) <u>Paris Pike:</u>

<u>Current</u> 2300 Paris Pike <u>New</u> 2324 Paris Pike

Section 2 – That the street names and property address numbers of the following properties be and hereby are changed as follows:

(a) <u>Chilesburg Road</u>: That the name of Chilesburg Road located at 100 is changed to Athens Boonesboro Road and the name of Chilesburg Road located at 160 and 150 is changed to Hannah Todd Place and the following number changes are made:

<u>Current</u> 100 Chilesburg Road 160 Chilesburg Road 150 Chilesburg Road

<u>New</u> 4301 Athens Boonesboro Road 300 Hannah Todd Place 316 Hannah Todd Place (b) <u>Innovation Drive</u>: That the name of Innovation Drive located at 2250 is changed to Jaggie Fox Way and the following number changes are made:

Current 2250 Innovation Drive <u>New</u> 2259 Jaggie Fox Way

(c) <u>Regency Circle</u>: That the name of Regency Circle located at 225 is changed to Regency Road and the following number changes are made:

Current 225 Regency Circle <u>New</u> 2025 Regency Road

Section 3 - That this Resolution shall be effective thirty (30) days from passage.
