Promotional Activities Involving Student-Athletes

NCAA rules require the University of Kentucky to present written approval for any student-athlete participating in any institutional, or noninstitutional charitable, educational, or non-profit activity or project considered incidental to the student-athlete's participation in intercollegiate athletics.

The University of Kentucky, the Southeastern Conference, or a noninstitutional charitable, educational, or non-profit agency may use a student-athlete's name, picture, or appearance to support its charitable or educational activities, but as stipulated under NCAA rules, a UK student-athlete may participate in an institutional, or noninstitutional charitable, educational, or non-profit promotion only under the following conditions:

- 1. Student-athlete receives written approval to participate from the Director of Athletics (or designee), subject to the limitations on participants in such activities as set forth in the NCAA regulations;
- 2. The specific activity or project in which the student-athlete participates does not involve co-sponsorship, advertisement, or promotion by a commercial agency. The sponsoring organization may reproduce their regular trademark or logo (along with their address and telephone number) only on printed materials such as pictures, posters, or calendars;
- 3. The name or picture of a student-athlete with remaining eligibility may not appear on an institution's printed promotional item (e.g., poster, calendar) that includes a reproduction of a product with which a commercial entity is associated if the commercial entity's officially registered regular trademark or logo appears on the item;
- 4. Student-athlete does not miss class;
- 5. All monies derived from the activity or project go directly to UK, the SEC, or the charitable, educational, or non-profit agency;
- 6. Student-athlete's name, picture, or appearance is not utilized to promote the commercial ventures of any non-profit agency;
- 7. Student-athlete and an authorized representative of the charitable, educational, or non-profit agency must sign a release statement ensuring that the student-athlete's name, image, or appearance will not be used for any commercial purpose;
- 8. Approval of this activity does not guarantee the appearance of a UK student-athlete.
