

MEMORANDUM OF AGREEMENT

This MEMORANDUM OF AGEEMENT (hereinafter "Agreement") is made on this the 30 day of August, 2018, by and between LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT, an urban county government organized pursuant to Kentucky Revised Statutes Chapter 67A, with a mailing address of 200 East Main Street, Lexington, Kentucky 40507 (hereinafter referred to as "LFUCG") and TOGETHER LEXINGTON, a unincorporated charitable organization, with a mailing address of 100 Midland Avenue, Lexington, Kentucky 40508 (hereinafter referred to as "Together Lexington").

WHEREAS, Together Lexington desires to install historical markers commemorating Lexington's African-American historical contributions through a twelve-sign cultural and historical walking tour; and,

WHEREAS, ten of the twelve markers to be erected are to be installed in LFUCG-owned or maintained right of way and donated to LFUCG;

NOW, THEREFORE, in consideration of the covenants contained herein, the parties hereby agree as follows:

1. Together Lexington may, at is sole expense, install historic markers, in a form to be approved by LFUCG in writing prior to installation, at the ten (10) locations designated on the attached Exhibit A. Upon installation and written approval of the signs as installed from LFUCG, all rights and privileges in and to the historical markers, including any warranties, held by Together Lexington shall permanently and irrevocably pass to LFUCG, without condition or exception.
2. LFUCG shall have no duty or obligation to conserve, maintain, or repair the historical markers. Should the markers fall into disrepair or conditions otherwise necessitate removal, LFUCG may remove or modify the markers. The Lexington Convention and Visitors Bureau ("VisitLex") shall have the right, with advance written approval from LFUCG, to perform maintenance and repairs upon the historical markers at such times and in such manner as LFUCG may allow.
3. LFUCG makes no representations, warranties, or guaranties to Together Lexington, whether express or implied, concerning the condition of the premises identified in Exhibit A. Together Lexington hereby releases LFUCG of any and all claims it may have or acquire against it for loss or damages of any nature arising, directly or indirectly, from the installation of the historical markers.
4. Together Lexington shall exercise due diligence at all times during the installation to ensure that installation is performed in a reasonably safe and prudent manner, and that all property on and surrounding the premises is protected and returned to its prior condition after installation is complete. Together Lexington shall exercise due diligence to ensure that the installation does not interfere with any other existing right in or on the property, including without limitation rights of easement held by utility and telecommunication services.
5. Prior to installation of the signs, this Agreement may be terminated by either party with thirty (30) days advance written notice to the other.




