Please be advised of the following clarifications to the above referenced RFP:

- Match is cash used to support project expenses and leverage is goods and services provided to
  clients using existing resources, i.e., housing assistance, toiletries, water, etc. Match and
  leverage amounts as specified in the RFP are required and proposals submitting lower amounts
  will be accepted but may not receive all available points.
- 3. There is not minimum target anticipated for the number of people placed in permanent housing, however, projects should set a target and track progress so that expectations can be established for future years. This may be evaluated in years 2 and 3 of the award.
- 4. Projects will be expected to enter all HUD Universal Data Elements into HMIS for participants who agree to and provide that information. Additionally, the VI-SPDAT common assessment must be administered on all willing participants.
