Seconded by Plomin. Motion passed without dissent.

Motion by Mossotti to approve recommendation #5, Changes to Section 26-13, eliminating Section 26-13(2)(c): "Advise that he or it is securing an independent appraisal at his expense within the next thirty (30) days" (as presented at the February 5, 2019 Planning & Public Safety Committee). Seconded by Plomin. Motion passed without dissent.

Motion by Mossotti to Approve to approve recommendations brought forward by the Subcommittee on Boards and Commissions (1) add two voting members to the Rural Land Management Board per the addition of Section 26-3(2)(j): "Two (2) members from a list of names submitted by the urban county council, with each council member submitting no more than one name, provided that each nominee be a leader and meet the qualifications specified in Section 26-3(2), and (2) add one ex-officio member to the Rural Land Management Board per section 26-3(c): "One (1) member of the Lexington Fayette Urban

County Council" (as presented at the February 5, 2019 Planning & Public Safety Committee). Seconded by Bledsoe. Motion passed without dissent.
