Motion by Farmer to approve the August 29, 2019 Council meeting docket. Seconded by Ellinger. Motion passed without dissent.

Motion by Worley to remove item 10 (an Ordinance amending Article 17 of the Lexington-Fayette Urban County Zoning Ordinance regarding signage to provide consistency within the various zones as to signage usage, to address signage size within each zone, to address transfer of signage square footage within each zone, and to address permitted signage and revisions to definitions within the Chapter; and amending Articles 8-21(o)(4)i, 8-24(o)(5), 22B-6, 24B-6(1), 28-3(h)(6), 28-4(h)(5) and 28-5(5) of the Zoning Ordinance of the Lexington-Fayette Urban County Government for purposes of reference to Article 17) and refer to the Planning and Public Safety Committee. Seconded by F. Brown. Motion passed without dissent.

Motion by Lamb to remove item 9 from the docket (an Ordinance amending Articles 6-4(d), 6-4(e), 6-5, and 6-6 and creating Articles 6-4(f) and 6-4(g) of the Zoning Ordinance adopting an alternative zone change process) and refer to the Planning and Public Safety Committee.
