Commander Ann Welch, Div. of Police, presented a disciplinary matter regarding Officer Jessie Mascoe. It is alleged that Officer Mascoe has committed the offense of: Violating Any Rules of the Department and Unsatisfactory Performance in violation of KRS 95.450 and General Order 1973-02J Disciplinary Procedures, Appendix B, Operational Rule 1.35 Violating Any Rules of the Division, specifically General Order 2011-08D Emergency and Pursuit Driving, Section V – Pursuits, Subsections A – General Procedures, Paragraph 1 and General Order 1973-02J, Disciplinary Procedures, Appendix B, Operational Rule 1.11 – Unsatisfactory Performance in that on the various days of February through June 2019 he/she allegedly:

On May 27, 2019 at approximately 1400 Hours, Officer Masco attempted to stop a vehicle in the area of Georgetown Road and Ash Street for a window tint violation. The vehicle fled from the stop and struck a fence and another vehicle while fleeing. Officer Masco pursued the vehicle with his emergency equipment activated. This is the second time Officer Masco has engaged in a vehicle pursuit contrary to policy. He received a Letter of Counseling on March 18, 2019 for the first violation of General Order 2011-08D Emergency and Pursuit Driving.

Since February 2019, Officer Masco has demonstrated a lack of performance, proficiency, and understanding in multiple areas.

On March 18, 2019 Sergeant Joshua Yahr met with Officer Masco to issue a Letter of Counseling regarding violations of the Emergency and Pursuit Driving Policy he observed on Body Worn Camera (BWC) during a pursuit on February 27, 2019 and a traffic stop on March 11, 2019.

On March 18th and on March 26, 2019 Officer Masco commits several traffic violations while looking for traffic offenders which resulted in formal charges for violation of General Order 1973-02J, Disciplinary Procedures, Appendix B, Operational Rule 1.13, Operation of Vehicles.

April 8, 2019 Officer Masco received a Letter of Counseling for failing to give a suspect their Miranda Warning, improper search/frisk procedures (Date of Incident [DOI]: March 26, 2019), and for failing to properly book evidence (DOI: March 27, 2019). The incident for March 26, 2019 was ultimately dismissed by the prosecutor, without prejudice, due to Officer Masco's tactics.

On May 27, 2019, Officer Masco was involved in a pursuit that was in violation of General Order 2011-08D Emergency and Pursuit Driving; this was Officer Masco's second pursuit that was in violation of policy.

On June 2, 2019 Officer Masco was issued a Coaching and Counseling Form for various issues including, but not limited to, improper BWC activation, improper searching procedures, improper documentation of a traffic stop, and failing to advise the subject the Miranda Warning (DOI: April 21, 2019). In addition to the documented counseling, Officer Masco attended formal retraining on June 14, 2019 regarding Search and Seizure and the Miranda Warning.

On June 21, 2019, Officer Masco drove his vehicle out of county without supervisory permission.

The appropriate punishment for this conduct is Two Months Suspension Without Pay, and, upon return to duty, Six Month Suspension of Home Fleet.

Ms. Evans asked, generally, about the effect of a long suspension on an officer's continued employment with the Lexington Police Department, and specifically, about the process for this disciplinary matter. Comm. Welch responded.

Upon motion by Mr. Farmer, seconded by Vice Mayor Kay, and approved by unanimous vote, the disciplinary recommendation was approved.
