- 5. **FORM OF PAYMENT:** Check, Cashier's Check, or Certified Funds.
- 6. CHECK PAYABLE TO: University of Kentucky

7. ADDITIONAL TERMS AND CONDITIONS:

a) PERFORMING SPACE: Purchaser agrees, at his own expense, to furnish the aforementioned Performing Space on the date and the time for the engagement herein contracted for, well heated, lighted, clean and in good order, clean dressing area for Artist near the stage, and clean and adequate dressing area for accompanist and assisting artist or artists, and all other items included, but not limited to, musicians, singers and stage managers. Purchaser also agrees to provide water for each performer.

- b) TEACHER'S GUIDE: Artist will furnish, through the UK Opera/SOOP website, to Purchaser a copy of the Teacher's Guide for "The Billy Goats Gruff". And the Purchaser agrees, at Purchaser's expense, to print and distribute a sufficient quantity of the Teacher's Guide materials furnished by Artist.
- c) IMPOSSIBILITY OF PERFORMANCE: Artist shall be under no liability for failure to appear or perform in the event that such failure is caused by or due to the physical disability of Artist, or acts or regulations of public authorities, labor difficulties, epidemic, civil tumult, strike, interruption or delay of transportation service, or any other similar or dissimilar cause beyond the control of Artist. If a subsequent date and time can be arranged, then Purchaser shall remain obligated in all respects of this agreement.
- d) EXCUSE FROM PERFORMANCE: This agreement is made in reliance upon Purchaser's good reputation for the prompt discharge of all obligations. In the event that Purchaser shall default in making payment for the services of any one or more artists engaged through or from the University of Kentucky or the Lexington Opera Society, Artist shall have the right to terminate this agreement by giving Purchaser notice in writing.
- e) RESTRICTIONS: Purchaser agrees to prevent the broadcasting, recording, or reproduction by radio, television or any other device of Artist's performance, or any part thereof.
- f) PERFORMANCE REFUSAL: In the event Purchaser refuses or neglects to provide any of the terms herein stated and/or fails to make any of the payments as provided herein, Artist shall have the right to refuse to perform this Agreement, shall retain amounts therefore paid to Artist by Purchaser, and Purchaser shall remain liable to Artist for the agreed price stated herein set forth.
