WHEREAS, the parties desire to amend said agreement;


NOW THEREFORE, in consideration of the following promises and covenants contained herein the parties hereby agree as follows:





 SCOPE OF WORK AND BUDGET**

Scope of Work:

The scope of work for this project includes PE, environmental, design engineering and Right-of-Way activities for new sidewalks along both sides of Armstrong Mill Road from Tates Creek Road to just beyond Greentree Road, where prefabricated pedestrian structures will be constructed to cross a culvert. The project also includes stormwater drainage, curb inlets, piping, manholes and headwalls.
