ATTACHMENT A SCOPE OF WORK AND BUDGET

Scope of Work:

The scope of work of this project is amended to include the construction of the Legacy Trail Phase III. These two projects were originally awarded a separate CMAQ and TE award. As the projects are adjacent to each other, Lexington-Fayette Urban County Government is being permitted to combine the construction phases of the two projects into one federal project that will be constructed at one time.

Budget:

The Budget of this project is amended to add CMAQ construction funds in the amount of \$212,000 with the \$53,000 match being provided via land value.
