AN ORDINANCE AMENDING CERTAIN OF THE BUDGETS OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT TO PROVIDE FUNDS FOR PURCHASE ORDERS AND PRE-PAID EXPENSES ROLLING FROM FY 2018 INTO FY 2019, AND APPROPRIATING AND RE-APPROPRIATING FUNDS, SCHEDULE NO 0002.

-) \$97,248.03 from the Unappropriated Fund Balance in the County Road Aid Program Fund to various accounts.
-) \$145,501.35 from the Unappropriated Fund Balance in the Mineral Severance Fund to various accounts.
-) \$2,834,068.16 from the Unappropriated Fund Balance in the Sanitary Sewer Revenue and Operating Fund to various accounts.

) \$447,751.24 from the Unappropriated Fund Balance in the Water Quality
Management Fund to various accounts.
) \$320,021.46 from the Unappropriated Fund Balance in the Landfill Fund to
various accounts.
) \$811.58 from the Unappropriated Fund Balance in the Right of Way Fund to
various accounts.
) \$1,237.60 from the Unappropriated Fund Balance in the Extended School
Program Fund to various accounts.
) \$475,561.94 from the Unappropriated Fund Balance in the Enhanced 911 Fund
to various accounts.
) \$4,440.00 from the Unappropriated Fund Balance in the Central Kentucky 911
Fund to various accounts.
