- Relationship has varied over time

# **Division of Planning**

- LFUCG and FCPS work together on several issues
  - School locations
  - Re-districting
  - Comprehensive Plan & long range planning
- FCPS is exempt from zoning regulations
  - Public Facilities review
- FCPS and other Local, State and Federal agencies are exempt from exactions fees



# **Division of Building Inspection**

- LFUCG policy to exempt FCPS from permit and plan review fees
- FCPS must still receive building permits and inspections, but they do not pay for them.
- Numerous times in the past FCPS started on construction projects without first receiving a building permit.



## **Division of Building Inspection**

- Construction projects from 2012-2017
  - Permit and Plan review fees- \$297,479
- A minimum of 6 times from 2012-2017 FCPS started projects without first receiving a permit
  - Permit and Plan review fees with fines- \$396,102



# **Division of Building Inspection**

- Estimated permit and plan review fees based on average school sizes:
  - Elementary School- \$15,850
  - Middle School- \$23,761
  - High School- \$61,927
