We have determined lease of this equipment is the most cost-efficient way to digitize plan, maps and other documents as part of the asset management plan required by the Consent Decree. The Lease is for three years at an annual cost of \$2,399.40 plus \$0.25 per square foot of print volume. Funds are budgeted. (L0608-17) (Martin/Hoskins-Squier)

Funds will also be used to provide education about BMP's and Stormwater quality. Funds are budgeted. (L0635-17) (Martin/Hoskins-Squier)

Economic Development Investment Board. The state has authorized the use of \$450,000 of economic development funding for Ashland's expansion. Ashland has requested to assign these agreements and their requirements to Valvoline. The total cost will be \$550,000. Funds are budgeted. (0637-17) (Atkins)
