## **Administrative Synopsis - New Business Items**

#### a 0836-17

Authorization to approve six (6) easements requested by Kentucky American Water Company on land comprising Pleasant Ridge Park and the Brighton Rail Trail and execution of the necessary documents required by KAWC and LFUCG. This work is associated with Kentucky American's Pleasant Ridge Main Improvements. KAWC will provide \$11,851.00 consideration of all six (6) easements. The address of each easement is: - 1350 Pleasant Ridge Dr. - Temporary Construction Easement, 1350 Pleasant Ridge Dr. - 20' Permanent Utility Easement, 1384 Pleasant Ridge Dr. - 20' Permanent and Variable Temporary Utility Easements, 3414 Polo Club Blvd. - Variable Permanent Utility Easement, 3278 Sweet Clover Ln. - Variable Permanent Utility Easement and 3240 Polo Club Blvd. - 20' Permanent Utility Easement.
