The purpose of this MOU is the commitment of both parties to the prevention of harm to self and others in compliance with applicable KY law, Federal law and Bluegrass professional ethical standards for law enforcement officials to be reasonably able to prevent or lessen a serious and imminent threat to the health or safety of an individual or the public. In addition to response services, this partnership also includes the training and education of Lexington Police Officers in the area of Crisis Intervention by Bluegrass.org. The Lexington Police Department will pay Bluegrass.org \$1,000 per training class of Lexington Police Department personnel for the enrollment in Crisis Intervention Training. Funds are budgeted.
