In order for the Lexington Police Department helicopter to operate safely, effectively and at the lowest possible cost, a sole source vendor must be established. Thoroughbred Aviation is located in Georgetown, KY and provides the Police Department service in a rapid manner within minutes of being called. There is no budgetary impact. The scope of the design is being increased to include a pedestrian bridge crossing Landsdowne Drive Tributary on the south side of Armstrong Mill Rd. and a signal at the intersection of Armstrong Mill Road and Greentree Road. Details of the change are shown on the contract modification form. Budget amendments are in process. (L0237-19) (Burton/Hamilton)
