BE IT RESOLVED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT:

Section 1 - That the Mayor, on behalf of the Lexington-Fayette Urban County Government, be and hereby is authorized and directed to execute Change Order No. Four (4), which is attached hereto and incorporated herein by reference, to the Contract with Lagco, Inc., for the construction of the Meadows/Northland/Arlington Public Improvements Project, Phases 5E & 5F, increasing the contract price by the sum of \$56,906.78 from \$2,451,178.90 to \$2,508,085.68.

Section 2 - That an amount, not to exceed the sum of \$56,906.78, be and hereby is approved for payment to Lagco, Inc., from account # 3120-303202-91713 pursuant to the terms of the Change Order.
