WHEREAS, it is necessary and proper to amend the Budgets of the Lexington-Fayette Urban County

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE LEXINGTON-FAYETTE

URBAN COUNTY GOVERNMENT:

Section 1 - That certain of the Budgets of the Lexington-Fayette Urban County Government be and hereby are amended to correct Budget related to purchase orders rolled to FY 2019 and purchase orders expensed to FY 2018, and that to effect such Amendments the following appropriations be and hereby are authorized and directed:

) \$\_953,322.96\_ \_from\_ the Unappropriated Fund Balance in the General Services District-General Fund \_to\_

various accounts.

) \$ 184,754.13 \_ \_from\_ the Unappropriated Fund Balance in the Full Urban Services District Fund \_to\_ various accounts.

) \$ 18,611.27 \_ \_from\_ the Unappropriated Fund Balance in the Police Confiscated Federal Fund \_to\_ various accounts.

) \$ 3,969.83 \_ \_from\_ the Unappropriated Fund Balance in the Police Confiscate State Fund \_to\_ various accounts.

) \$ 850.00 \_ \_from\_ the Unappropriated Fund Balance in the Mineral Severance Fund \_to\_ various accounts.

) \$ 248,073.36 \_ \_from\_ the Unappropriated Fund Balance in the Sanitary Sewer Revenue and Operating Fund \_to\_ various accounts.

) \$ 207,848.28 \_ \_from\_ the Unappropriated Fund Balance in the Water Quality Management Fund \_to\_ various accounts.

) \$ 3,099.53 \_ \_from\_ the Unappropriated Fund Balance in the Landfill Fund \_to\_ various accounts.

) \$ 22,200.90 \_ \_from\_ the Unappropriated Fund Balance in the Enhanced 911 Fund \_to\_ various accounts.

) \$ 417.51 \_ \_from\_ the Unappropriated Fund Balance in the Central Kentucky 911 Fund \_to\_ various accounts.

) \$ 125,594.25 \_ \_from\_ the Unappropriated Fund Balance in the Medical Insurance Fund \_to\_ various accounts.

Section 2 - That the purposes of the Budget Amendments and the Accounts to or from which funds are herein appropriated, are detailed in "BUDGET SCHEDULE NO. 0007", attached hereto and incorporated herein by reference.
