Authorization to approve the second of four (4) annual renewals (effective April 1, 2017 through March 31, 2018) for work associated with the MS4 Program Management Agreement with Tetra Tech, Inc., per Resolution #658-2014/RFP #57-2014, following the expiration of the second Contract term ending March 31, 2017, per Resolution #700-2015. The renewal option with Tetra Tech, Inc., is for continued services associate with compliance measures of LFUCG's Consent Decree related to the Storm Sewer System and with its KPDES MS4 permit.
