(\$457,000.00) from account number 1101-900101-0001-71101; (2) The Downtown Lexington Corporation d/b/a Downtown Lexington Partnership (\$363,470.00) from account number 1101-900111-0001-71101; (3) LexArts, Inc. (\$489,050.00) from account number 1101-900109-0001-71101; (4) The Lyric Theatre and Cultural Arts Center, Inc. (\$150,000.00) from account number 1101-900107-0001-71101; (5) Urban League of Lexington - Fayette County, Inc. (\$90,000.00) from account number 1101-900206-0001-71101; and (6) Kentucky World Trade Center, Inc. d/b/a World Trade Center Kentucky (\$55,000.00) from account number 1101-900104-0001-71101, pursuant to the terms of the respective Purchase of Service Agreements.
