WHEREAS, it is necessary and proper to amend the Budgets of the Lexington-Fayette Urban County Government for various FY2018 projects as presented at the April 17, 2018 Council Budget Retreat and appropriating and re-appropriating funds:

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT:

Section 1 - That certain of the Budgets of the Lexington-Fayette Urban County Government be and hereby are amended to provide funds for various FY2018 projects as presented at the April 17, 2018 Council Budget Retreat and appropriating and re-appropriating funds:

) Re-appropriations within the General Services District Fund and General Fund Capital Projects that do not result in changes to the Unappropriated Fund Balances of this fund.
