A Resolution authorizing and directing the Mayor, on behalf of the Urban County Government, to execute a Memorandum of Agreement with Ky. Community and Technical College System on behalf of Bluegrass Community and Technical College, for college courses, at a cost not to exceed \$76,290. [Div. of Police, Weathers]

Authorization to accept the Memorandum of Agreement with the Kentucky Community and Technical College System (KCTCS) on behalf of Bluegrass Community and Technical College (BCTC). The purpose of this MOA is to enter into this Agreement to set forth and ensure compliance with any and all terms and conditions of the participation of Police personnel in College courses associated with the Police Academy, with the opportunity for these personnel to earn BCTC credits that apply toward an Associate of Applied Science Degree. The term of this Agreement commences on approximately July 1, 2018 and ends on June 30, 2019. Parties shall have an option to renew the MOA under the same terms and conditions set forth in this Agreement. Renewals shall be on an annual basis. Estimated cost with 10 enrolled students - \$25,430, 20 enrolled students - \$50,860, 30 enrolled students - \$76,290. Estimated cost is fully Budgeted. (L0780-18) (Weathers/Armstrong)
