A Resolution authorizing and directing the Mayor, on behalf of the Urban County Government, to execute an Accreditation Agreement with the Council on Accreditation, for reaccreditation of the Dept. of Social Services, at a cost not to exceed \$26,595. [Dept. of Social Services, Ford] Authorization to execute an Accreditation Agreement with the Council on Accreditation, for reaccreditation of the Department of Social Services. Reaccreditation through COA is required every four years, and the Department of Social Services has been accredited continuously since the early 1980's. COA Reaccreditation fees are \$18,695.00 if Fiscal Year 2017 and the Site Visit cost will be approximately \$7,900.00 in Fiscal Year 2018. Funds are Budgeted. (L0872-16) (Ford)
