Section 3 - That the following subsection line numbers in the Classified Civil Service authorized strength be and hereby are amended to read as follows:

Section 4 - That the incumbent, Chelanda Holliday, be and hereby is reclassified from Administrative Specialist, Grade 513N, at \$19.606 hourly to Administrative Specialist Sr., Grade 516N, at \$21.959 hourly.

Section 5 - That the incumbent, Sharon Smith, be and hereby is reclassified from Social Worker Sr., Grade 516E, at \$2,093.92 biweekly to Case Management Coordinator, Grade 520E, at \$2,387.04 biweekly.
