#### GOVERNMENT:

Section 1 - That certain of the Budgets of the Lexington-Fayette Urban County Government be and hereby are

amended to reflect current requirements for funds in the amount of \$20,000 in the Division of Facilities and Fleet

Management from the Council Projects Fund for fabrication/installation of a new street sign at the LFUCG Versailles

Road Campus and that to effect such Amendments the following appropriations be and hereby are authorized and

directed:

Section 2 - That the purposes of the Budget Amendments and the Accounts to or from which funds are herein appropriated are detailed in Schedule No. 0004 attached hereto and incorporated herein by reference.
