) Re-appropriations within the General Services District Fund; Donations Fund; 2014 Bond Projects Fund; Sanitary Sewer Construction Fund; Extended School Program Fund; and the various Grant funds which do not result in changes to the Unappropriated Fund Balance of these funds.
