BE IT ORDAINED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY

GOVERNMENT:

Section 1 - That Section 12-8.4 of the Code of Ordinances of the Lexington-Fayette Urban

County Government be and hereby is created to read as follows:

(a). Accumulation of snow upon a sidewalk so as to endanger the public health and safety by

preventing the safe and reasonable flow of pedestrian traffic is hereby declared a nuisance.

(b). Any person who causes or maintains a nuisance in violation of subsection (a) of this

section is subject to the abatement procedure provided in Section 12-7 of this code subject to the

following:

(1). The owner of property abutting any sidewalk shall clear the sidewalk after any snow event

with an accumulation of four (4) or more inches.

(2). The owner of property on which a sidewalk abuts any street must have such sidewalk

cleared within twenty-four (24) hours of the end of the snow event.

(3). The end of the snow event shall be indicated on the government's website, in public

communications made by the government related to the end of the snow event and in any notice of

violation.

(c). The government shall not issue a notice of violation for a violation of this section if the

street abutting the property has not been plowed.

(d). In the event of the presence of extreme weather conditions, the Mayor or his designee

May hold the enforcement of this section in abeyance until conditions improve. Any such

announcement will be made on the government's website and in all public communications made by

the government during and immediately following the snow event.

Section 2 - That this Ordinance shall become effective on the date of its passage.
