WHEREAS, pursuant to Code of Ordinances Section 18-51 and other authorities, the Division of Traffic Engineering is authorized and empowered to maintain traffic-control signs, signals, and devices deemed necessary to regulate traffic; and

WHEREAS, the Urban County Council has determined that Mitchell Avenue between Clays Mill Road and Southland Drive should have traffic calming devices;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT:

Section 1 - That the Division of Traffic Engineering is authorized and directed to install four (4) speed tables on Mitchell Avenue between Clays Mill Road and Southland Drive per guidelines in the Neighborhood Traffic Management Program.

Section 2 - That an amount not to exceed \$18,000.00 is approved for the installation of four (4) speed tables on Mitchell Avenue between Clays Mill Road and Southland Drive from account 1136-303601-91614.

Section 3 - That this Resolution shall become effective on the date of its passage.
