WHEREAS, the Urban County Council passed a map amendment zoning Ordinance on November 17, 2016 to change the zone from a Professional Office (P-1) zone to a High Rise Apartment (R-5) zone for properties located at 353 Waller Avenue; and

WHEREAS, the Ordinance inadvertently omitted conditional zoning restrictions which were recommended by the Planning Commission and included in the minutes from the Planning Commission hearing but inadvertently omitted from the final report of the Planning Commission: and WHEREAS, the inadvertent omission of the conditional zoning restrictions should be included in the Ordinance but do not change the substance of the map amendment to the zoning Ordinance; NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT:

Section 1 - That Ordinance No. 4-2017 be and hereby is amended to include the following as a new section two and to renumber existing sections two and three to section three and four as follows:

- b. Boarding and Lodging Houses
- c. Assisted Living Facilities
