Authorization to abolish one (1) vacant classified position of Administrative Specialist Sr. (Grade 516N) and one (1) vacant classified position of Public Service Worker Sr. (Grade 509N) and create one (1) classified position of Computer Analyst (Grade 520E) in the Division of Computer Services and one (1) classified position of Equipment Operator (Grade 510N) in the Division of Streets and Roads, effective upon passage of Council.
