Section 1 - That the bid of New Cingular Wireless PCS, LLC, d/b/a AT&T Mobility Corporation, submitted in accordance with the provisions of Ordinance No. 69-2016, creating and offering for sale a franchise for the operation of a non-exclusive telecommunications (or related non-cable) system in Fayette County, a copy of which is attached to the Franchise Agreement as Exhibit "B", is hereby declared to be a highest and best bidder for said franchise; and said franchise is hereby sold to and

vested in New Cingular Wireless PCS, LLC, for the period of time provided in the Ordinance and franchise Agreement.
