Section 1 - That Strothman and Company, Certified Public Accountants and Advisors, be and hereby is authorized to conduct a financial audit of all Lexington-Fayette Urban County Government Funds for Fiscal Year 2017 for an amount not to exceed \$151,500.00 (FY2018), and the Mayor, on behalf of the Lexington-Fayette Urban County Government, be and hereby is authorized to execute the Letter Agreement, which is attached hereto and incorporated herein by reference, and any other necessary documents with Strothman and Company related to the audit.

Section 2 - That an amount, not to exceed the sum of \$151,500.00 (FY2018) be and hereby is approved for payment to Strothman and Company from account #1101-202101-71202 (\$86,577.43), account #1115-202101-71202 (\$15,435.48), account #1181-202101-71202 (\$374.19), account #4002-202101-71202 (\$31,806.45), account #4121-202101-71202 (\$11,974.19), account #4022-202101-71202 (\$767.10), and account #4051-202101-71202 (\$4,565.16), subject to these funds being included in the FY2018 Budget as adopted by the Urban County Council.
