Section 3 - That an amount, not to exceed the sum of \$113,642.05 be and hereby is approved for payment to Oracle America, Inc., from account #1101-202505-76102, subject to inclusion of this item in the approved FY 2018 Budget and subject to the appropriation of sufficient funds in future fiscal years.

Section 4 - That this Resolution shall become effective on the date of its passage.
