Authorization to execute a Right-of-Way Agreement with Columbia Gas of Kentucky to permit a new permanent easement 20' wide by approximately 250' long in Veterans Park to install a new 4" low pressure gas line. Columbia Gas of Kentucky will abandon approximately 3000' of high pressure gas line easement currently in Veterans Park and provide \$2,500 for consideration of the new easement.
