Section 1 - That the Mayor, on behalf of the Lexington-Fayette Urban County Government, be

and hereby is authorized and directed to execute and submit a Grant Application, which is attached

hereto and incorporated herein by reference, to the Kentucky State Police-Vehicle Enforcement

Division, to provide any additional information requested in connection with this Grant Application,

and to accept this Grant if the application is approved, which Grant funds are in the amount of

\$60,000.00 Federal funds, and are for the continued operation of the Motor Carrier Safety Assistance

Program (MCSAP) for FY 2018, the acceptance of which obligates the Lexington-Fayette Urban

County Government for the expenditure of \$10,588.24 as a local match, which will be provided from

documentation of existing Division of Police staff salaries.
