BE IT RESOLVED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT:

Section 1 - That the Division of Engineering be and hereby is authorized to procure a crossing signal, related equipment, and installation services from R.J.
