BE IT RESOLVED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY

Section 1 - That the Mayor, on behalf of the Lexington-Fayette Urban County Government, be and hereby is authorized and directed to execute the Agreement, which is attached hereto and

incorporated by reference, with the Kentucky Transportation Cabinet (KYTC), for the exchange of approximately 34.658 Rd. lane miles located in Lexington-Fayette County, with KYTC to receive approximately 19.6 Rd. lane miles and the Urban County Government to receive approximately 15.058 Rd. lane miles.

Section 2 - That the Mayor, or his designee, be and hereby is authorized to sign any necessary documents related to the exchange.

Section 3 - That this Resolution shall become effective on the date of its passage.
