Authorization to execute an Agreement with Telcordia Technologies Inc., d/b/a iconectiv, as a sole vendor under Contract with the Federal Communications Commission to manage telephone number (landline, wireless and VoIP) portability between carriers. E911 accesses the database to resolve issues when calls to 911 do not present location and/or carrier information as they should. The annual cost is \$6,000. Funds are Budgeted.
