Section 1 - That the Mayor, on behalf of the Lexington-Fayette Urban County Government, be and hereby is authorized to execute Change Order No. 1, which is attached hereto and incorporated herein by reference, to the Agreement with ZKB Service LLC, for the Versailles Road Tornado Shelter Project, increasing the Contract price by the sum of \$5,000 to include prevailing wage rates, from \$26,500 to \$31,500.
