NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT:

Section 1 - That certain of the Budgets of the Lexington-Fayette Urban County Government be and hereby are amended to reflect current requirements for funds in the \$13,429.37 to provide funds for Council Projects in the Division Public Safety for

facilities maintenance, repairs and improvement to Animal Care and Control and that to effect such Amendments the following appropriations be and hereby are authorized and directed:

Section 2 - That the purposes of the Budget Amendments and the Accounts to or from which funds are herein appropriated are detailed in Schedule No. 0027 attached hereto and incorporated herein by reference.

Section 3 - That this Ordinance shall become effective on the date of its passage.
