Authorization to execute a Health Services Agreement with Corizon, Inc for the offender medical services at the Division of Community Corrections. The current contract with Corizon expires at the end of the fiscal year. This amendment will be a one-year extension to the contract. The fourth amendment includes increased staffing, coverage of AIDS medications, and an increase to the aggregate CAP to cover outside medical costs. Total base compensation not to exceed \$5,197,475.
