BE IT RESOLVED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT:

Section 1 - That the Mayor, on behalf of the Lexington-Fayette Urban County Government, be and hereby is authorized to execute the Memorandum of Agreement, which is attached hereto and incorporated herein by reference, with Blue Grass Community Foundation, Inc., to contribute \$100,000.00 to the Breaking the Bronze Ceiling Campaign for the creation of a monument to celebrate the history of women in Lexington, Kentucky.

Section 2 - That an amount, not to exceed the sum of \$100,000.00, be and hereby is approved for payment to Blue Grass Community Foundation, Inc., from account 1101-155001-0001-71299, pursuant to the terms of the Agreement.
