A Resolution authorizing the Mayor, on behalf of the Urban County Government, to execute a lease agreement with Pilgrim Baptist Church for use of auxiliary parking at 541 Jefferson St. for one (1) year, with two (2) automatic annual renewals, at a cost not to exceed \$1,000 per year. Authorization to enter into/renew a lease agreement with Pilgrim Baptist Church for the city's usage of an auxiliary parking lot on church property located adjacent to the church at 541 Jefferson Street, to serve as overflow parking for Coolivan Park, which lacks adequate parking on LFUCG property. BE IT RESOLVED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT:

Section 1 - That the Mayor, on behalf of the Lexington-Fayette Urban County Government, be and hereby is authorized to execute the Lease Agreement, which is attached hereto and incorporated herein by reference, with Pilgrim Baptist Church for use of auxiliary parking at 541 Jefferson Street for one (1) year, with two (2) automatic annual renewals.

Section 2 - That an amount, not to exceed the sum of \$1,000.00 per year, be and hereby is approved for payment to Pilgrim Baptist Church from account 1101-707606-7641-71301-775, pursuant to the terms of the Lease Agreement.

Section 3 - That this Resolution shall become effective on the date of its passage.
