BE IT RESOLVED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT:

Section 1 - That the Mayor, on behalf of the Lexington-Fayette Urban County Government, be and hereby is authorized and directed to execute and submit the Grant Application, which is attached hereto and incorporated herein by reference, to the Kentucky Department of Education, Division of School and Community Nutrition, to provide any additional information requested in connection with this Grant Application, and to accept this Grant if the application is approved, which Grant funds are in the amount of \$79,000.00 Federal funds, are for participation in the United States Department of Agriculture's Child Care Food Program and operation of the nutrition program at the Family Care Center in FY 2019, and the acceptance of which does not obligate the Lexington-Fayette Urban County Government for the expenditure of funds.
