BE IT RESOLVED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT:

Section 1 - That the Mayor, on behalf of the Lexington-Fayette Urban County Government, be and hereby is authorized and directed to accept deeds of easement and to execute any documents necessary for the acquisition of right-of-way, to facilitate the Town Branch Trail Mid-Block Crossing Project.
