WHEREAS, it is necessary and proper to amend the Budgets of the Lexington-Fayette Urban County

Government to reflect current requirements for municipal expenditures:

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE LEXINGTON-FAYETTE

URBAN COUNTY GOVERNMENT:

Section 1 - That certain of the Budgets of the Lexington-Fayette Urban County Government be and hereby are amended to reflect current requirements for municipal expenditures, and that to effect such Amendments the following appropriations be and hereby are authorized and directed:

-) \$ 5,049,205.12 from the Sanitary Sewer Revenue and Operating Fund to various accounts.
-) \$_44,947.00 _ to _the Water Quality Management Fund _from_ various accounts.
-) \$_5,004,258.12 __to_ the Sewer Trust Fund _from_ various accounts.
-) Re-appropriations within the General Services District Fund; Sewer Construction Fund; and the various Grant funds that do

not result in changes to the Unappropriated Fund Balance of these funds.
