BE IT RESOLVED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT:

Section 1 - That the Mayor, on behalf of the Lexington-Fayette Urban County Government, be and hereby is authorized to execute certificates of consideration and other necessary documents, and to accept deeds of easement from owners of record for property interests needed for the Shandon Park Trunk, Winburn Trunk, and Thoroughbred Acres Trunk Sewers Project, a Remedial Measures Project required by the Consent Decree, at a cost not to exceed \$36,235.25.

Section 2 - That an amount, not to exceed the sum of \$36,235.25, be and hereby is approved for payment to property owners, plus usual and appropriate closing costs, all from account # 4003 - 303408 - 92811 at the time of closing.

Section 3 - That this Resolution shall become effective on the date of its passage.
